SPECIAL IMPACT FEE TO RECOVER UPGRADE INVESTMENT

This schedule sets the amounts for a special impact fee to recover upgrade investments in the Zion Ponderosa area (see attached Map), authorized in the Rules and Regulations of Garkane Energy Cooperative, Inc.

The impact fee shall be based upon the service entrance main breaker and/or fuse sets amperage and nominal service voltage. Where there are more than one service entrance main breakers and/or fuse sets the impact fee shall be based upon the sum of such devices.

NEW SUBDIVISIONS

The Special Impact Fee shall be assessed to the developer in addition to impact fees as noted in Schedule SC.

ESTABLISHED SUBDIVISIONS

In an established subdivision where the Schedule SC Impact Fee has already been paid by the developer, the Special Impact Fee shall be assessed to the consumer once the lot has been sold and the lot owner requests service. The Special Impact Fee shall be in addition to impact fees as noted in Schedule SC.
